

IGFA GRAND SLAM CLUBS

For purposes of the IGFA Grand Slam Club, an Offshore Grand Slam is defined as an individual angler catching or catching and releasing three different species of billfish in a single day under IGFA rules. Four different species equals a Super Grand Slam. An Inshore Grand Slam is three of the four following species: Snook, Tarpon, Permit, and Bonefish. Catching all four in one day qualifies for a Super Grand Slam. A Mediterranean Grand Slam is three of the four following species: Albacore, Bluefin Tuna, Spearfish, and Swordfish. Catching all four in one day qualifies for a Super Grand Slam. The species for Pacific Offshore are bluefin tuna, yellowfin tuna, bigeye tuna and any billfish. The North Pacific slam consists of a Chinook Salmon, Steelhead/Rainbow trout and Dolly Varden. The Pacific Inshore species are white seabass, yellowtail, halibut and dorado. The Atlantic Offshore species are bluefin tuna, yellowfin tuna, bigeye tuna or mako shark. The Atlantic Inshore species are striped bass, bluefish, weakfish, Atlantic bonita and little tunny. The Tuna Grand Slam consists of yellowfin, bluefin, bigeye and albacore.
