

IGFA GRAND SLAM CLUBS



For purposes of the IGFA Grand Slam Clubs, catching three species in one day equals a Grand Slam, and four different species equals a Super Grand Slam. Details on the eligible species for each Slam Club can be found in the *World Record Game Fishes* book or online at http://igfa.org/Fish/IGFA-Clubs.aspx.

All catches, past and present are eligible as long as they have been caught during a single calendar day and in accordance with IGFA rules. It is not necessary to kill the fish, and the IGFA encourages catch and release. Photos of the angler with the fish and the contact information of the captain and/or witness are required for catches made after January 1, 2012.
